Horse Travel

The Dubai Racing Carnival selection committee will only consider **horses rated 105 and above** for travel subsidies.

Additionally, **2yo** (2025) – **3yo** (2026) will be entitled for shipping subsidies if they finish in the **first 3 in any Meydan pattern race** or if they achieve a rating of 95 and above at the end of the carnival.

Furthermore, travel incentives will be decided on a horse-by-horse basis.

Dubai Racing Club (DRC) will cover the cost of return **air freight** for each incentivised horse for the Dubai Racing Carnival, based on **three horses per pallet** on existing scheduled service cargo routes, from their country of origin, or nearest country/airport with scheduled service cargo routes to/from Dubai and return to the same point, together with affiliated charges for UAE import/export.

For 2yo (2025) – 3yo (2026), connections must pay the air freight for their horse to come to Dubai but if their horses reaches the subsidy threshold to receive the incentive, DRC will **reimburse** the cost of the **air freight** to Dubai, to the trainers DRC account, and cover the cost of the air freight to return the horse to its point of origin.

For UK/EU origin horses, the use of charter flights will be optimised and wherever possible will be used in preference to schedule line flights. Should owners wish to make alternative arrangements relating to the return of their horses, they will be responsible for all charges applicable to this change, however Janah will be able to advise.

Incentivised horses must **run at least twice** at Meydan to retain their incentive. If the horse is sold privately or at public auction in the UAE, the return portion of the transport subsidy is forfeited.

All horse should leave Dubai at the end of the of Dubai Racing Carnival. Owners wishing to leave their horses in Dubai after the Dubai Racing Carnival must gain approval from the DRC.

All GCC horses, whether transported by road or air, will be coordinated through DRC and Janah Management. No allowance will be issued.

Trainers will need to make their own arrangement for them and their staff to travel to and out of Dubai.

Any international horse subsequently INVITED to run at the Dubai World Cup Meeting 2026, that is already resident in Dubai, will be eligible for benefits as per the Dubai World Cup policy.

* Please note: If the UK import conditions change in the interim period, connections will be advised through Janah agents.

IMPORT CONDITIONS

Import Conditions

Horses from all countries will need to meet, as a minimum, the UAE temporary import conditions appropriate to the country of origin. All horses will be stabled in designated quarantine facilities based on their country of origin, separated from local horses. Access to these areas will be restricted.

Post Arrival Recovery Period

- Horse arriving in the UAE will **be restricted** to their allocated stabling at the quarantine facility for up to **48 hours**, depending on the length of journey
- Horses that travel for less than six (6) hours (stable to stable) will be confined for a minimum of 12 hours after their arrival at the quarantine facility
- Horses travelling for more than six (6) hours (stable to stable) will be confined for a minimum of 48 hours after their arrival at the quarantine facility

During this time, they **will not be allowed out** to the main track or training track. They will be closely monitored for recovery from the journey and appropriate testing will be performed based on country of origin.

Exercise will be permitted within the confines of the facility with each facility having a trotting ring.

Vaccination Requirements

Equine influenza vaccination requirements for permanent entry into UAE is compulsory.

Within 60 days of export but **NOT within 14 days** of export the horse must be administered the following:

- A valid primary course consisting of two vaccinations 21-42 days apart with the **same brand of vaccine** (both doses must be administered within the 60 days but not within 14 days of travel).
- Or a booster to a valid primary vaccination (21-42 days apart with the same vaccine) – boosters must be given within 12 months of the primary course, and within 12 months of each booster vaccination. The most recent booster must be within 60 days but not within 14 days of shipping.

If the primary course in the passport does not meet with the required 21–42-day interval, or both doses were not given with the **same vaccine** then a new primary course **MUST** be given.

If there is more than **six months between any booster** doses a new primary course **MUST** be given.

If you are considering sending your horse to the DUBAI RACING CARNIVAL, please urgently send a coloured scan of the passport vaccination pages to Janah so that they can advise if there is any action to take in this regard to ensure shipping

QUARANTINE SUMMARY

Dubai Racing Carnival Quarantine Summary

UK and EU origin

- Remain in quarantine during all stay
- Training within quarantine training slots
- Allow to race in all races at Meydan (Jebel Ali and Abu Dhabi only in group/graded/listed races)
- Can go to compete in group/graded races in Bahrain, Qatar, KSA on this import permit
- Can **go straight back** to its country of origin providing all conditions are met and quarantine rules strictly abided to.

Staff Accommodation

Free onsite accommodation will be provided for **subsidised horses** on a 1 for 3 horses' basis.

Limited additional onsite accommodation available on a shared basis for a monthly fee of € 1,000 + 5% VAT per person.

Overflow of stable staff will be accommodated at a hotel designated by the DRC.

Stabling Facilities

International horses for the Dubai Racing Carnival will be stabled at either Dubai World Cup Quarantine Stables or International Quarantine Stables, both of which are located at Meydan Racecourse.

International Quarantine is primarily used for UK and EU horses. Dubai World Cup Quarantine is used for horses from other countries.

These facilities are located adjacent to Meydan Racecourse, and approximately a 25 minutes' drive from Dubai International Airport. Once the horses land in Dubai, DRC Quarantine Grooms and DRC quarantine horse boxes will transport the horses from the airport to the quarantine facilities.

The quarantine stables also provide stable staff and riders with on-site accommodation as well as a recreational room and swimming pool. Staff will also receive breakfast and dinner, complimentary of the DRC at the quarantine facilities, that will be provided by a DRC appointed caterer.

In the DRC quarantine stables there will be no cost related to:

1. Provision of boxes
2. DRC quarantine stables security staff
3. Use of any Meydan training facility
4. Use of shared administration office

DRC grooms will be available to assist all international horses on a one groom per 3 horse basis. The DRC grooms are there to assist visiting staff only and will NOT be held responsible for the care of the horses. The horses are always the **responsibility of the trainer's** staff and DRC staff will not be held responsible for the horse/s in the absence of trainer or his/her employees.

PRIZE MONEY

Prize Money for the Dubai Racing Carnival is disbursed in accordance with ERA rules and regulations, with the following percentages applicable.

Owner	75%
Trainer	10%
Jockey	10%
Stable Staff (Paid to the Trainer Account)	5% to be distributed amongst the stable staff

Each Trainer, Owner and Jockey must submit an online account payment form comprising of Beneficiary bank details to Dubai Racing Club with their account details.

Entry fee as well as riding fee will be charged onto the owners Emirates Racing Authority account. Entry fees are charged as per the condition book published by Emirates Racing Authority. Riding fees are charged at a total of **₹ 500** credited to the jockey's account and **₹100** credited to the Jockey's insurance fund.

Carnival Prize money payments distribution will be remitted to all the winners after 2026 Dubai World Cup.

All the signed forms must be submitted by the Owner/Trainer/Jockey before the 2026 Dubai World Cup, no forms will be accepted thereafter the Dubai World Cup 2026.
